This pilot project closed effective September 30, 2022. All Clubs developed under this project will have their dues graduated up to the appropriate level over the time frame of October 1, 2022, through September 30, 2025. Effective October 1, 2025, newly formed International Development Clubs follow the billing structure and rates as outlined in the Optimist International Bylaws.

New Club's First Payment of International Dues

Annual dues shall commence on the first day of the third month following the month in which the Club is officially organized. Such initial payment will be based on the number of Members enrolled in the International Office on the last day of the month prior to the billing date. The new Club will be invoiced covering the months in which the calculations are made.
